ROUTINE MAINTENANCE AND SPOT IMPROVEMENT OF VARIOUS ROADS

The Kenya Rural Roads Authority (KeRRA) is a State corporation established under the Kenya Roads Act, 2007, with the responsibility for Management, Development, Rehabilitation and Maintenance of rural roads.

The Authority hereby invites bids from eligible Construction Companies to bid for Routine Maintenance and Spot Improvement Works on various roads in the counties listed below to be financed by the Government of Kenya through the Road Maintenance Levy Fund, Development Vote and Equalization Fund.

1. MANDATORY REQUIREMENTS

Eligible bidders must meet and attach the following mandatory requirements among others:-

- a) Tender forms correctly filled, signed and stamped.
- b) Certified copy of certificate of incorporation.
- c) Copy of practicing licence certificate of registration with the NCA
- d) Certified copy of pin registration certificate.
- e) Copy of Valid Tax Compliance certificate.
- f) Certified copy of CR12 form.
- g) Proof of registration by the Treasury in special groups (**Women, Youth & Physically Challenged Persons**) for Small Engineering Works (for all tender for special groups).
- h) Certified copy of National Identity card/passport for **Youth**.
- i) Pre-tender site visit certificate (Signed & Stamped) by the respective Regional Managers
