The Kenya Rural Roads Authority (KeRRA) is a State corporation established under the Kenya Roads Act, 2007, with the responsibility for management, development, rehabilitation and maintenance of rural roads.

The Authority hereby invites bids from eligible Construction Companies to bid for Upgrading, Rehabilitation and Spot Improvement of Various Roads to be financed by the Government of Kenya through the Road Maintenance Levy Fund and Development Vote.
