## TENDER NOTICE ADDENDUM NO. 1

### SUPPLY, INSTALLATION AND MAINTENANCE OF; DOOR ACCESS CONTROL SYSTEM (DACS) AT KeRRA OFFICES KeRRA/011/37/01/2019-2020

Reference is made to the Tender Notice that appeared in the Authority's website and in Local Dailies, dated **8<sup>th</sup> August 2019**.

Interested Bidders are requested to note the following amendments in the tender documents as per the requested clarifications from the bidders during the pre-tender site visit meetings.

1. Under Section V: Schedule of Requirements, The Table: Pricing Table/Guidelines provided on page 26 has been revised as follows;

2. Under Section VI Clause 6.2, the following additional specifications have been incorporated;
  - a) To ensure emergency exits complies fully with Occupational Health and safety act, 2007, the emergency exits should not be fitted with biometric readers but instead with magnetic locks triggered by resettable break glass.
  - b) The bidder shall ensure a system is in place to track the breach on emergency doors by triggering alerts to specific staff in form of SMS and or emails.
  - c) A central control panel and a sounder should be installed at KeRRA datacenter that will be triggered when the emergency door security is breached and visually communicate/display the information on the affected door.
  - d) The Door Access Control System should track both entries and exits.
3. Under Section VI: Description of Services Clause 6.2, Item No. Ix Has Been Expunged.
