- f) **Valid** Tax Compliance Certificate
- g) **Pre-tender site visits.** The bidders are encouraged to make personal arrangement to acquaint themselves with the site before submission of the bids and Certificate for site visit form signed.
- h) Litigation history as a sworn affidavit in the last 3 months
- i) Duly filled and stamped form of bid with 192 days’ tender validity from tender date

- c) National Council for persons with Disabilities Certificate (PWD).
- d) Certified Copy of CR12 indicating directors, shareholding & Copies directors of IDs or Passport.
- e) **Valid** National Construction Authority practicing licence as a road works contractor NCA 8 and above.
- f) VAT registration Certificate
- g) **Valid** Tax Compliance Certificate
