5. Tender documents may be obtained electronically from the www.tenders.go.ke and Authority's Website www.kerra.go.ke from 24th July, 2024.

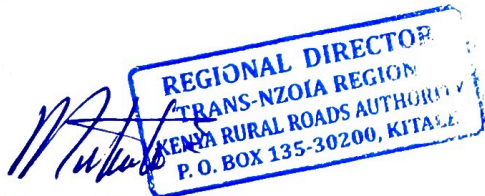
