# **QUALIFICATION FOR TENDERING**

## **Mandatory Requirements**

Eligible bidders **MUST** meet and submit the following with the bid:

- a. Must be prequalified in KeRRA Busia Region.
- b. Certified copy of Certificate of Incorporation
- c. **Copy** of a **valid** NCA certificate and practicing license as a contractor (Roads & Civil Works NCA 8 and above)
- d. Copy of Valid VAT & PIN registration certificate
- e. Copy of **Valid** Tax compliance certificate (Will be verified on the KRA TCC Checker)
- f. **Certified** copy of CR 12 (Issued within the last 12 months from the tender opening date)
- g. Certified copies of National Identity Cards/Passports of Directors.
- h. Certified copy of Valid Single Business Permit
- i. **Certified** copy of **Valid** Certificate of Registration for Access to Government Procurement Opportunities (AGPO), from the National Treasury (For Disadvantaged groups, Women, Youth and Persons with Disability). **Note:** All Contractors bidding for **PWD** tenders must attach **certified** copies of their Identity Cards as issued by the National Council for Persons with Disability.
- j. Certified copies of Log books for ownership of Machines and Equipment. Those hiring Must provide certified copies of Lease Agreements and certified copies of Log books, valid not more than three months from the date of tender opening.
- k. Current Sworn Affidavit not more than 3 months from the tender opening date
- 1. **Proof** of having opened a bank account in the contractor's name
- m. Audited accounts for the last three financial years.
- n. Form of tender correctly filled, signed & stamped on company letterhead
- o. Confidential Business Questionnaire correctly filled, signed & stamped.
- p. Ensure all schedules as provided in the bid document are appropriately filled.
- q. Authority to seek reference from Contractors' bank well written and attached.
- r. Bidders **must serialize sequentially** all pages of their tender documents.
- s. Valid Pre-tender site visit certificate
- t. The bidder must **sequentially serialize** all the pages of the bid document.
- u. All other qualifications as outlined in the tender document

- 1. All certification of documents shall be original and executed by a Commissioner for Oaths or Notaries Public.
- 2. Certificates/ Licenses/ previous experience will be verified with the Issuing Authorities or Agencies
- 3. Pre-tender site visit is a mandatory requirement
- 4. All attachments must be legible.
