

The Authority, **Narok Region**, hereby invites sealed bids from eligible and registered contractors in Category C, D, and E in Narok Region for Maintenance of various roads for FY 2023-2024. Bidders Interested in tenders reserved for **AGPO Enterprises** are not required to have registered in the Region.
