1. The Kenya Rural Roads Authority (KeRRA) is a state corporation established under the Kenya Roads Act 2007, with the responsibility of management, development, rehabilitation and maintenance of Rural Roads.
2. The Authority hereby invites bids from interested and eligible Suppliers for the Tender for Upgrading and Installation of Local Area Network (LAN), Related Infrastructure and Maintenance Services set to be financed through the RMLF Vote.
3. The Tender Document will be available for downloading **FREE OF CHARGE** on the Authority's Website [www.kerra.go.ke](http://www.kerra.go.ke) and PPIP Portal <http://www.tenders.go.ke> with effect from **30<sup>th</sup> May, 2024**.

6. Errors in the pricing of the Price Schedule will not be corrected. Bidders with such errors will be disqualified.
7. All pages of the submitted documents are to be Serialized from the First page to the last page.
8. Completed tender documents should be enclosed in plain sealed envelopes, clearly marked with the Tender Name, Tender Number and be deposited in the Tender Box located at the Ground Floor, Barabara

Plaza Block B, or be addressed and posted to the address below on or before **20<sup>th</sup> June, 2024 at 11.00 a.m.**

9. Bulky tenders which do not fit in the Tender Box shall be delivered to the Supply Chain Management Office located on the 3rd Floor, South Wing, Barabara Plaza, Block B.
10. Opening of the bids will take place immediately thereafter at the Ground Floor Board Room, Barabara Plaza, Block B **in the presence of the tenderers or their representatives who choose to attend.**
