This will be conducted as per the conditions of tender and instructions to Bidders Clause 7.1-Pre-tender site Visit arrangements will be between 4th November, 2024-8th November, 2024.
- 4.MUST provide original document and a copy.
- 5.All Interested bidders are required to continually check the KeRRA website www.kerra.go.ke/tenders for any tender addendum or clarification that may arise before the submission date.
- 6.Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.

- b) The cost estimate of the proposed works has been provided in the tender document.
