- Bidders are notified that this tender is prepared under the new public procurement regulatory authority conditions and format and criteria and it.
- To enhance equity, bidder will be awarded a maximum of **ONE TENDER** either as a company or director under this **TENDER NOTICE**.
- Pretender site visit is **MANDATORY**, and bidders are requested to make their own arrangements in consultation with the Regional Director's office and ensure their pretender site visit certificate is signed and stamped.
- All forms must be filled and authorized appropriately – no unnecessary attachments


The Authority wishes to inform interested eligible bidders as follows

1. Tendering will be conducted under National open competitive tendering for special groups (AGPO) restricted tendering for registered bidders using a standardized tender document. Tendering is open to all qualified and interested Tenderers. Tendering is *open to all Small and Medium Enterprises registered appropriately with youth, women & people with disability certification*.
2. Qualified and interested tenderers may obtain further information and inspect the Tender Documents during office hours *8.30 am to 4.30 pm* at the address given below.
3. Detailed information on the tenders will be available for downloading **FREE of CHARGE** on the Authority's Website [www.kerra.go.ke](http://www.kerra.go.ke) as from 21<sup>st</sup> November 2024
4. Bidders are requested to familiarize themselves with the site before tendering. Bidders are further advised to liaise with respective Constituency Roads Officers to sign pretender site visit register and obtain a dully stamped, signed form.
5. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
6. Front loading of quotations is discouraged. Too low or too high bids will be assessed and disqualified accordingly as per tender document.
7. Bidders are advised to read the criteria in the PE requirement section thoroughly before filling the documents
8. **The estimates for each tender are as provided in the other supplementary information under the PE requirement**



9. Bidders should have their documents paginated (serialized) to ensure compliance with section 74 (1) (I) of the Public Procurement and Asset Disposal Act, 2015. This should be in the format 1,2,3,4,5..... from the First Page up to Last Page).
10. Bidders can type in the documents Erasing out the instructions for ease of tender preparations – minimal attachment required. Forms not dully filled shall lead to being nonresponsive
11. Completed tenders must be delivered to the address below on or before **11:00 am. 5th December 2024**. Electronic Tenders *will not* be permitted.
12. Tenders will be opened immediately after the deadline date and time specified above or any deadline date and time specified later. Tenders will be publicly opened in the presence of the Tenderers' designated representatives who choose to attend at the address below.
13. Late tenders will be rejected.
