2. Bidders are requested to familiarize themselves with the site before tendering. Site Visits are open but **MANDATORY** for all Bidders upto 5<sup>th</sup> December, 2024. Site visit certificate will be issued per road.
3. The bidders to ensure that their rates in the bills of quantities are within the known prevailing market rates for road works pursuant to Section 70(6) (b) of PPADA, 2015 read together with Regulation 43(4) of the Public Procurement and Asset Disposal Regulations, 2020
4. All Interested bidders are required to continually check the KeRRA website [www.kerra.go.ke/tenders](http://www.kerra.go.ke/tenders) for any tender addendum or clarification that may arise before the submission date.
