Bidders must provide original document and a copy.
- 6) Bulky Tender Documents which do not fit in the Tender Box shall be delivered to the reception office of the Regional Office at the address provided above.
- 7) Opening of the bids will take place immediately thereafter in the presence of the tenderers or their representatives who choose to attend at the address provided above.

- 8) Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
- 9) To enhance equity, bidders will only be awarded a Maximum of Two (2) Tenders, under this Tender Notice in the region which are the most advantageous to the Employer.
- 10) Director(s) bidding under different companies for the same tender will be disqualified.
- 11) Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
- 12) All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page as required in this tender document.
- 13) All interested bidders are required to continually check the Kenya Rural Roads Authority website: www.kerra.go.ke for any tender addendums or clarifications that may arise before submission date.
