Bidders MUST **meet the following requirements alongside** other requirements **contained in the tender** documents.

- 1. To enhance equity bidders will only be awarded a maximum of (02) two tenders either as a director or a company under this tender notice.
- 2. Pretender site visit is mandatory, and bidders are requested to make their own arrangements in consultation with the Regional Director's Office and ensure their pretender site visit certificate is signed and stamped. (within the first 10 days of the notice).

- 3. For pretender site visit all bidders' representatives must have an introduction letter from the company.
- 4. MUST submit original tender document and a copy.
- 5. All Interested bidders are required to continually check the KeRRA website <u>www.kerra.go.ke/tenders</u> for any tender addendum or clarification that may arise before the submission date.

Qualifications for those bidding under category "Open"

- a) Must be registered in the respective Constituency in Tana River Region in the Financial Year 2023/2025.
- b) Certified Certificate of Incorporation
- c) Current copy of CR12
- d) **Valid** National Construction Authority Certificate and Practicing Licence for road works in the categories indicated above.
- e) Attach VAT registration Certificate
- f) Valid Tax Compliance Certificate
- g) Litigation history as a sworn affidavit in the last 3 months
- h) Duly filled and stamped form of bid with 192 days' tender validity from tender date
- i) Duly filled Bid document including Tender questionnaire, Anti- Corruption pledge, Environmental & Social Commitment undertaking, confidential business questionnaire, and Bills of Quantities.
- j) Serialized document in all pages
- k) Equipment holding necessary to undertake the project (if owned attach evidence) if not owned attach valid lease agreement
- 1) Audited accounts for previous financial years/Proof of Bank account
- m) CVs and Certificates of technical staff.

Qualifications for those bidding under Access to Government Opportunities (AGPO) under categories; Youth, Women and People Living with Disabilities, need not to be registered in the constituency but must provide the following;

- a) Certified Certificate of Incorporation
- b) Current certified Registration Certificate with National Treasury under the category of Small Works and Engineering (PWD, Youth or Women)
- c) National Council for persons with Disabilities Certificate (PWD).
- d) Certified Copy of CR12 indicating directors, shareholding & Copies directors of IDs or Passport.
- e) Valid National Construction Authority Certificate and Practicing Licence for road works in the categories indicated above.
- f) VAT registration Certificate
- g) Valid Tax Compliance Certificate

- h) Litigation history as a sworn affidavit in the last 3 months
- i) Duly filled and stamped form of bid with 192 days' tender validity from tender date
- j) Duly filled Bid document including Tender questionnaire, Anti- Corruption pledge, Environmental & Social Commitment undertaking, confidential business questionnaire, and Bills of Quantities.
- k) Serialized document in all pages
- 1) Equipment holding necessary to undertake the project (if owned attach evidence) if not owned attach valid lease agreement
- m) CVs and Certificates of technical staff.

NOTE:

- All attachments must be certified by a Commissioner for Oaths.
- The cost estimate of the proposed works has been provided in the tender document.
