### UPGRADING TO BITUMEN STANDARDS, SPOT IMPROVEMENT AND ROUTINE MAINTENANCE OF VARIOUS ROADS

1. The Kenya Rural Roads Authority (KeRRA) is a state corporation established under the Kenya Roads Act 2007, with the responsibility of management, development, rehabilitation and maintenance of Rural Roads.
2. The Authority hereby invites sealed tenders from eligible bidders for the Upgrading to Bitumen Standards, Spot Improvement & Routine Maintenance of various Roads (Batch 1) as lotted below.
  - i. Lot 1 & 2A – to be submitted at KeRRA Head Office (Barabara Plaza, Block B),
  - ii. Lot 2B – to be submitted at respective Regional Offices.

9. Opening of the bids will take place immediately thereafter in the presence of the tenderers or their representatives who choose to attend.
10. Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
11. To enhance equity, bidders will only be Awarded a Maximum of **Two (2)** Tenders, under this Tender Notice and the most advantageous to the employer.
12. Director (s) bidding under different companies for the same tender will be disqualified.
13. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
14. All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page.
