Kenya Rural Roads Authority (KeRRA) is a state corporation established under the Kenya Roads Act 2007 with the responsibility for management, development, rehabilitation and maintenance of Rural Roads network in the country.

The Authority hereby invites interested Road works Contractors **REGISTERED** in Kwale Region for financial years 2023-2025 and those within the **Special Category** (YWPD) for Routine Maintenance projects.

- 1. To enhance equity bidders will only be awarded a maximum of one (1) tender as a firm or Director, under this Tender Notice provided they are the most advantageous to the Employer.
- 2. Director(s) bidding under different companies for the same tender will be disqualified.
- 3. Pre-Tender site visit shall be open but **MANDATORY**. Bidders are requested to familiarise themselves with the site before tendering through making personal arrangements in consultation with the Regional Director's office and ensure that their pre-tender site visit certificates are signed and stamped by the Regional Director/or his representative. This will be conducted as per the conditions of tender and Instructions to Bidders Clause 7.1-Pre-tender site Visit arrangements will be from **16**<sup>th</sup> **June**, **2025**.
- 4. MUST provide 2 documents of the tender (original document and a copy).
- 5. Bulky tenders which do not fit in the Tender Box shall be delivered to the Supply Chain Management Office.
- 6. All Interested bidders are required to continually check the KeRRA website <u>www.kerra.go.ke/tenders</u> for any tender addendum or clarification that may arise before the submission date.
- 7. Errors in the pricing of the Bills of Quantities will not be corrected pursuant to clause 74(2) of the public procurement and asset disposal regulations, 2020. Bidders with such errors will be disqualified.

- 8. All attachments must be certified by a commissioner for oaths.
- 9. The cost estimate of the proposed works has been provided in the tender document.
- 10. Interested contractors are advised to download tender documents from the KeRRA website at www.kerra.go.ke. for free from **Friday 13<sup>th</sup> June, 2025.**
- 11. Completed tender documents (**Original and One (1) Copy**) should be enclosed in plain sealed envelopes, clearly marked with Tender Name and Tender Number and **deposited in the Tender Box at the Kenya Rural Roads Authority, Kwale Regional Office or be addressed and Posted to address indicated below so as to be received on or before Thursday, 26<sup>th</sup> June, 2025 at 11.00 a.m.**
