### UPGRADING/ STAGE CONSTRUCTION AND REHABILITATION OF VARIOUS ROADS

The Kenya Rural Roads Authority (KeRRA) is a state corporation established under the Kenya Roads Act, 2007, with the responsibility for management, development, rehabilitation and maintenance of rural roads.

1. The Authority hereby invites bids from eligible tenderers for Upgrading/ Stage Construction and Rehabilitation of various roads to be financed by the Government of Kenya through the Equalization & Development Vote.

8. Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
9. To enhance equity, a bidder will only be awarded a maximum of One **(1)** Tender as a Firm or Director, under this Tender Notice and the most advantageous to the employer.
10. Director (s) bidding under different companies for the same tender will be disqualified.
11. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
12. **Clarity on Serialization of Tender Documents**  
All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page.
