Pretender site visit is MANDATORY and bidders are required to attend organised pretender site visit before tendering through making their own personal transport arrangements and ensure that their pre-tende site visit certificate are signed and stamped by Regional Director or his representative. This will be conducted as per the conditions of tender and instructions to Bidders Clause 7.1 .Pre-Tender site visit arrangements will be on 3rd July, 2025 for MWINGI WEST and KITUI EAST CONSTITUENCIES and 4th July 2025 for KITUI CENTRAL, KITUI SOUTH AND KITUI RURAL CONSTITUENCIES
- 4. All Interested bidders are required to continually check the KeRRA website www.kerra.go.ke/tenders or www.tenders.go.ke for any tender addendum or clarification that may arise before the submission date.
- 5. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
