The Kenya Rural Roads Authority (KeRRA) is a State corporation established under the Kenya Roads Act, 2007, with the responsibility for management, development, rehabilitation and maintenance of rural roads.

1. The Authority hereby invites bids from eligible Construction Companies to bid for Spot Improvement of various roads in Tana River Region to be financed by the Government of Kenya through the Development Vote.
2. Bidders are required to download full details of the tender documents from the Authority's website [www.kerra.go.ke](http://www.kerra.go.ke) from 02<sup>nd</sup> May, 2025.

5. Opening of the bids will take place immediately thereafter in the presence of the tenderers or their representatives who choose to attend.
6. Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
7. To enhance equity, bidders will only be Awarded a Maximum of **One (1)** Tender, under this Tender Notice and the most advantageous to the employer.
8. Director (s) bidding under different companies for the same tender will be disqualified.
9. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.

**10. Clarity on Serialization of Tender Documents**

All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page.
