- 7) Opening of the bids will take place immediately thereafter in the presence of the tenderers or their representatives who choose to attend at the address provided above.
- 8) Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
- 9) To enhance equity, bidders will only be awarded a Maximum of **Two (2)** Tenders, under this Tender Notice which are the most advantageous to the Employer.
- 10) Director(s) bidding under different companies for the same tender will be disqualified.
- 11) Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
