This will be conducted as per conditions of the tender and instructions to bidders clause 7.1 – Pre-Tender site visit arrangements will be between **28th October 2025 to 7th November 2025**.

7. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified
