This will be conducted as per the conditions of tender and Instruction to Bidders Clause 7.1
3. Bulky tenders which do not fit in the Tender Box shall be delivered to the Supply Chain Management Office and registered.
4. All interested bidders are required to continually check the KeRRA website www.kerra.go.ke/tenders for any tenderers' addendum or clarification that may arise before the submission date. Bidders who download the tender document must forward their particulars immediately to samburu.proc@kerra.go.ke to facilitate any clarification or addendums.
5. Errors in the pricing of the Bills of Materials will not be corrected. Bidders with such errors will be disqualified.
6. **Clarity on Serialization of Tender Documents**
All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page.
7. Interested bidders are required to continually check the Kenya Rural Roads Authority website: www.kerra.go.ke or www.tenders.go.ke any tender addendums or clarifications that may arise before submission date.
8. To enhance equity bidders will only be awarded a Maximum of two (2) tenders, under this tender Notice in the region which will be the most advantageous to the employer.
