INSTRUCTION TO BIDDERS

Bidders **MUST** meet the following requirements alongside the other requirement contained in the tender document;

1. Bidders are notified that this tender is prepared under the new public procurement regulatory authority conditions, format, criteria, and it.
2. To enhance equity, bidder will be awarded a maximum of **ONE TENDER** either as a company or director under this **TENDER NOTICE**.
3. Pretender site visit is **MANDATORY**, and bidders are requested to make their own arrangements in consultation with the Regional Director's office and ensure their pretender site visit certificate is signed and stamped.
4. All forms must be filled and authorized appropriately
5. Detailed information on the tenders will be available for downloading **FREE of CHARGE** on the Authority's Website www.kerra.go.ke as from **28th October, 2025**.
6. Bidders are requested to familiarize themselves with the site before tendering and further advised to liaise with respective Constituency Roads Officers to sign pretender site visit register and obtain a dully stamped, signed form.
7. Bidders shall provide **ORIGINAL** document and a **COPY**

8. All certified documents shall be original and executed by Commissioner for Oaths clearly marked "Certified True Copy of the Original"
9. Bidders are advised to read the criteria in the TENDER DOCUMENT thoroughly before filling the documents
10. The estimates for each tender are as provided in the other supplementary information.
11. Bidders should have their documents paginated (**Machine Serialized**) to ensure compliance with section 74 (1) (b) of the Public Procurement and Asset Disposal Act, Revised 2022. This should be in the format 1,2,3,4,5..... from the First Page up to Last Page).

Qualified and interested tenderers may obtain further information and inspect the Tender Documents during office hours 8.30 am to 4.30 pm at the address given below.

Completed tenders must be delivered in **Wax Sealed Plain Envelopes** marked with Tender Reference (**KeRRA/KIR/08.....**) number and description to the address below or deposited in the **Tender Box** located within the Kenya Rural Roads Authority **Kirinyaga Region Offices** (opposite Kerugoya Boys) situated along Baricho Road on or before **10th November, 2025 at 10:00 am.**

Tenders will be opened immediately after the deadline date and time specified above or any deadline date and time specified later. Tenders will be publicly opened in the presence of the Tenderers' designated representatives who choose to attend at the address below.

Late tenders will be rejected.
