3. All Interested bidders **MUST** provide **One (1)** Original Tender Document
4. All Interested bidders are required to continually check the KeRRA website www.kerra.go.ke/tenders for any tender addendum or clarification that may arise before the submission date.
5. Opening of the bids will take place immediately thereafter in the presence of the tenderers or their Representatives who choose to attend.
6. Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
7. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
8. The cost estimate of the proposed works has been provided in the tender document.
9. **Clarity on Serialization of Tender Documents**
All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page
