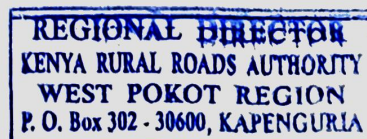

Bidders are requested to familiarise themselves with the site before tendering through making their own personal arrangements in consultation with Regional Director's Office and Ensure that their pre-tender site visit certificates are signed & stamped by the Regional Director or His Representative. This will be conducted as per the conditions of tender and instructions to bidders Clause 7.1.pre-tender site visit arrangements will be between 22nd October 2025 to 11th November, 2025 during normal working hours.
4. Bidders **SHALL** provide **ORIGINAL** document and **COPY**.

5. All Interested bidders are required to continually check the KeRRA website www.kerra.go.ke/tenders for any tender addendum or clarification that may arise before the submission date.
6. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.

- a) All certification of documents shall be original and executed by Commissioner for Oaths or Notaries Public. They shall be clearly marked 'Certified True copy of the Original
 - b) The cost estimate of the proposed works has been provided in the tender document.
