6. Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
7. To enhance equity, bidders will be Awarded a Maximum of **Two (2)** Tenders under this Tender Notice.
8. Director (s) bidding under different companies for the same tender will be disqualified.
9. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
10. **Clarity on Serialization of Tender Documents**
All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page.
