- 3. Bidders are requested to familiarise themselves with the site before tendering through making their own personal arrangements in consultation with the Regional Director's office

and ensure their pretender site visit certificate is signed and stamped by the Regional Director or his representative. This will be conducted as per the conditions of tenders and instructions to Bidders Clause 7.1 – Pre-tender site visit arrangements will be (within the first 10 days of the tender notice)

- 4. For pretender site visit all bidders' representative must have an introduction letter from the Company.
- 5. MUST provide one tender document written "original and another written "copy".
- 6. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be dis-qualified.
