Bidders are requested to familiarize themselves with the site before tendering through making their own personal arrangements in consultation with the Regional Director's Office and ensure that their pre-tender site visits certificates are signed and stamped by the Regional Director/ or his representative. This will be conducted as per the conditions of tender and instructions to Bidders Clause 7.1-pre-tender site visit arrangements and

issuing of pretender site visit certificate will close on 21st November, 2025

4. All Interested bidders are required to continually check the KeRRA website www.kerra.go.ke/tenders for any tender addendum or clarification that may arise before the submission date.
5. Errors in the pricing of the Bills of Materials will not be corrected. Bidders with such errors will be disqualified.

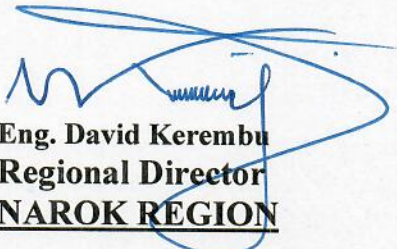
