TENDER NOTICE (LONG ADVERTISEMENT)

UPGRADING, SPOT IMPROVEMENT & CONSTRUCTION OF DRAINAGE STRUCTURES ON VARIOUS ROADS FOR THE FY 2025/2026

The Kenya Rural Roads Authority (KeRRA) is a state corporation established under the Kenya Roads Act, 2007, with the responsibility for management, development, rehabilitation and maintenance of rural roads.

1. The Authority hereby invites bids from eligible Construction Companies to bid for Upgrading, Spot Improvement & Construction of Drainage Structures on Various Roads to be financed by the Government of Kenya through the Road Maintenance Levy Fund, Development Vote, and Equalization Funds.

10. Director (s) bidding under different companies for the same tender will be disqualified.
11. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
12. All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page.
13. All interested bidders are required to continually check the Kenya Rural Roads Authority website: www.kerra.go.ke for any tender addendums or clarifications that may arise before submission date.
