Bidders **MUST** meet the following requirements alongside **other requirements** contained in tender **documents**.


1. To enhance equity bidders will only be awarded a maximum of two (2) tenders under this tender notice in the Region which are the most advantageous to the Employer.

Pretender site visit is **MANDATORY** and bidders are required to attend an organised pretender site visit before tendering through making their own personal transport arrangements and ensure that their pre-tender site visit certificate are signed and stamped by Regional Director or his representative. This will be conducted as per the conditions of tender and instructions to Bidders Clause 7.1 .Pre-Tender site visit **DATES** will be as follows:

**30<sup>ST</sup> DECEMBER 2025 for Kitui Central Constituency and Kitui South Constituency, Tenderers to converge at KeRRA Kitui Office at 10:00am**
