4. Completed tender documents should be enclosed in plain sealed envelopes, clearly marked with the Tender Name, Tender Number and deposited in the Tender Boxes at the Region Office of the address provided above on or before **the stipulated closing date per tender in the above table.**

5. Bulky Tender Documents which do not fit in the Tender Box shall be delivered to the reception office of the Regional Office at the address provided above.
6. Opening of the bids will take place immediately thereafter in the presence of the tenderers or their representatives who choose to attend at the address provided above.
7. Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
8. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
9. **Clarity on Serialization of Tender Documents:** All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page.
10. All interested bidders are required to continually check the Kenya Rural Roads Authority website: www.kerra.go.ke and PPIP Portal www.ppip.go.ke for any tender addendums or clarifications that may arise before submission date.
