This will be conducted as per the conditions of tender and Instruction to Bidders Clause 7.1
2. Bulky tenders which do not fit in the Tender Box shall be delivered to the Supply Chain Management Office and registered.
3. All interested bidders are required to continually check the KeRRA website [www.kerra.go.ke/tenders](http://www.kerra.go.ke/tenders) for any tenderers addendum or clarification that may arise before the submission date. 4. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
