2. Pre-Tender site visit shall be open but Mandatory. Bidders are requested to familiarise themselves with the site before tendering by making their own personal arrangements in consultation with the Regional Director's office and ensure that their pre-tender site visit certificates are signed and stamped by the Regional Director or his/her representative as per clause 7.1 of instruction to bidders. The pre-tender site visit arrangements shall be between **20th and 21st January 2026**.

3. All Interested bidders MUST provide Original Tender Document
4. All Interested bidders are required to continually check the KeRRA website www.kerra.go.ke/tenders for any tender addendum or clarification that may arise before the submission date.
5. Certification of attachments must be done, dated and signed by a commissioner for oaths.
6. The cost estimate of the proposed works has been provided in the tender document.
7. All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page.
8. The bid documents will be available on the KeRRA Website as from **12th January 2025**
