6. Submit a written power of attorney authorizing the signatory of the bid to commit the Bidder Executed by a Commissioner for Oaths, in accordance with ITT 21.3.

Completed tender documents should be enclosed in plain sealed envelopes, clearly marked with the Tender Name, Tender Number and be deposited in the respective tender boxes at the offices of Regional Directors on or before the dates indicated above for various tenders at 11.00 a.m. on the address below.
8. Bidders should have their documents paginated (serialized) to ensure compliance with section 74 (1) (i) of the Public Procurement and Asset Disposal Act, 2015. This should be in the format 1,2,3,4,5 from the First Page up to Last Page).

10. Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
