Bidders are requested to familiarize themselves with the site before tendering through making their own personal arrangements in consultation with the Regional Director's Office and Ensure that their Pre-Tender site Visit certificates are signed and stamped by the Regional Director or his representative. This will be conducted as per conditions of the tender and instructions to bidders clause 7.1 – Pre-Tender site visit arrangements will be between 7th April 2026 to 14th April 2026.
5. Must Provide **One (1) Original Tender document**
6. All Interested bidders are required to continually check the KeRRA website www.kerra.go.ke/tenders for any tender addendum or clarification that may arise before the submission date.
7. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified
