The Kenya Rural Roads Authority (KeRRA) is a state corporation established under the Kenya Roads Act, 2007, with the responsibility for management, development, rehabilitation and maintenance of rural roads.

1. The Authority hereby invites bids from eligible Construction Companies to bid for Spot Improvement of various roads in Tana River Region to be financed by the Government of Kenya through the Development Vote.
2. Bidders are required to download full details of the tender documents from the Authority's website www.kerra.go.ke from 15th June, 2025.

6. Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
7. To enhance equity, bidders will only be Awarded a Maximum of **One (1)** Tender, under this Tender Notice.
8. Director (s) bidding under different companies for the same tender will be disqualified.
9. **Clarity on Serialization of Tender Documents**
All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page.
10. Interested bidders are required to continually check the Kenya Rural Roads Authority website: www.kerra.go.ke for any tender addendums or clarifications that may arise before submission date.
