Pretender site visit is **MANDATORY** and bidders are required to attend an organised pretender site visit before tendering through making their own personal transport arrangements and ensure that their pre-tender site visit certificate are signed and stamped by Regional Director or his representative. This will be conducted as per the conditions of tender and instructions to Bidders Clause 7.1 .Pre-Tender site visit **DATES** will be as follows:

23RD JUNE 2026 for Mwingi North, Mwingi Central and Mwingi West Constituencies, Tenderers to converge at KeRRA Mwingi Office at 10:00am.

24TH JUNE 2026 for Kitui West Constituency and Kitui Rural Constituency, Tenderers to converge at KeRRA Kitui Office at 10:00am

25ST JUNE 2026 for Kitui Central Constituency and Kitui South Constituency, Tenderers to converge at KeRRA Kitui Office at 10:00am

4. All Interested bidders are required to continually check the KeRRA website www.kerra.go.ke/tenders or www.tenders.go.ke for any tender addendum or clarification that may arise before the submission date.
5. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
