- 3) Completed tender documents should be enclosed in plain sealed envelopes, clearly marked with the Tender Name, Tender Number and deposited in the Tender Boxes at the Region Office of the address provided above on or before the stipulated closing date per tender in the above table. Bidders must provide original document and a copy.
- 4) Bulky Tender Documents which do not fit in the Tender Box shall be delivered to the reception office of the Regional Office at the address provided above. Opening of the bids will take place immediately thereafter in the presence of the tenderers or their representatives who choose to attend at the address provided above.
- 5) Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
- 6) To enhance equity, bidders will only be awarded a Maximum of Two (2) Tenders, under this Tender Notice in the region which are the most advantageous to the Employer.
- 7) Director(s) bidding under different companies for the same tender will be disqualified. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.
- 8) All pages of the tender documents submitted by bidders shall be sequentially serialized including the cover page as required in this tender document.
