2. The Authority hereby invites bids from interested and eligible Service Providers for the Provision of Motor Vehicle Insurance Services at KeRRA for a Period of Two (2) Years to be financed through the RMLF Vote.

4. All Tenders must be accompanied by a Kenya Shillings Two Hundred Thousand Only [KShs. 200,000.00] Tender Security.
5. Errors in the pricing of the Price Schedule will not be corrected. Bidders with such errors will be disqualified.
6. All pages of the submitted documents are to be Serialized from the First page to the last page.

Completed tender documents should be enclosed in plain sealed envelopes, clearly marked with the Tender Name, Tender Number and be deposited in the Tender Box located at the Ground Floor, Barabara Plaza Block B, or be addressed and posted to the address below on or before **8th July, 2026** at **11.00 a.m.**
8. Bulky tenders which do not fit in the Tender Box shall be delivered to the Supply Chain Management Office located on the 3rd Floor, South Wing, Barabara Plaza, Block B.

10. Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
