5. Errors in the pricing of the Bills of Quantities will not be corrected. Bidders with such errors will be disqualified.

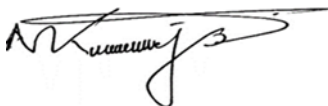
- a) All attachments must be certified by a commissioner for oaths.
